Objectives and Investment Policy

Objective: The aim of the Fund is to increase the value of an investment over a minimum of 5 years. The Fund will do this through a combination of capital growth, which is profit on investments held, and income received by the Fund, which is money paid out of investments, such as dividends and interest.

Management style: The Investment Manager actively manages the Fund, deciding which investments to buy or sell and when.

Policy: The Fund will invest at least 80% in collective investment schemes, investment trusts and exchange traded funds (collectively "Investment Funds"). This could include other Investment Funds managed by the Authorised Corporate Director or the Investment Manager. The Investment Funds held can be active or passive (which means that the decision on which investments to buy or sell is made based on the performance of an underlying index) funds.

Through these Investment Funds, the Fund will gain exposure to at least 80% in shares in companies, across both developed and emerging markets, with no minimum or maximum exposure to any geographic region.

It may also gain up to 20% exposure to other asset types such as:

- Real assets, for example property and commodities (e.g. gold and oil);
- Absolute return funds, which aim to deliver positive returns in all market conditions;
- Bonds, which are loans typically issued by companies, governments and other institutions, may be either investment grade, where the issuer has a high and reliable capacity to repay the debt, or sub-investment grade, which can be more vulnerable to changing market conditions but typically pay a higher rate of interest; and
- Money market funds, which invest in short term loans.

The Fund may hold up to 20% in cash, including foreign currency and equivalents.

The Fund will not use derivatives, but the Investment Funds it invests in may use them to varying degrees.


The management of the Fund will be appropriate to the Fund's risk profile so that any potential returns are balanced with appropriate risk taking.

The Fund is rated 9 on the Investment Manager's internal risk rating, which categorises the risk of the Fund based on its exposure to different assets. This risk classification ranges from 1 (lowest risk) to 10 (highest risk). This Fund has a high level of risk, characterised by higher levels of investments into shares, rather than lower risk investment types, like bonds. The Fund's risk rating is not the same as the risk and reward category shown below.

Assessing performance: The trade body, Investment Association (IA), groups funds into sectors based on similar characteristics. This Fund belongs to the IA Global sector. You may want to assess the Fund's performance compared to the funds in this sector noting the sector includes a variety of funds with global diversification in company shares. Some funds focus on specific industries or have different geographic asset allocations, which may lead the Fund to outperform or underperform the sector.

Other information: This Fund does not pay out income, all income from investments will be added to the value of your shares. You can buy or sell all or part of your investment on any business day subject to the minimum holding requirements.

Risk and Reward Profile

This Fund has been measured as 5 because its investments have experienced moderate to high volatility in the past. The Fund's volatility is affected by various risks, including:

Market risk: The Fund will be exposed to financial markets and market conditions can change rapidly. Prices can move irrationally and be affected unpredictably by diverse factors, including political and economic events.

Smaller company risk: The Fund may be exposed to the shares of smaller companies which are typically riskier than larger, more established companies. Difficulty in trading may arise, resulting in a negative impact on your investment. Shares in smaller companies may be harder to sell at a desired price and/or in a timely manner, especially in difficult market conditions.

Emerging market risk: The Fund may be exposed to emerging markets, which are typically riskier than more established markets, as they can involve a higher than average risk due to the volatility of currency exchange rates, limited geographic

focus, investment in a smaller number of issues, political and economic instability and less liquid markets. Difficulty in trading may arise, resulting in a negative impact on your investment.

Fixed Income / credit risk: The Fund may be exposed to bonds, the prices of which will be impacted by factors including: changes in interest rates, inflation expectations and perceived credit quality.

Foreign exchange (currency) risk: The Fund may have exposure to overseas markets, either directly or indirectly, and is therefore exposed to currency risk. As a result, the value of your investment can be affected by changes in exchange rates.

Liquidity risk: In certain market conditions, the Fund may not be able to sell one or more of its assets for the full value, or at all. This could affect the performance of the Fund and could cause the Fund to defer or suspend redemptions of its shares, meaning investors may not be able to have immediate access to their holdings.

Counterparty risk: A company that we deal with may renege on its obligations, costing the Fund money.

Operational risk: Operational processes, including those related to the safekeeping of assets, may fail. This may result in losses to the Fund, or inconvenience to investors.

Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment. The ongoing charges figure is based on expenses as at 30/06/2025. This figure may vary from year to year. It excludes:

- Portfolio transaction costs, except in the case of an entry/exit charge paid by the Fund when buying or selling units in another collective investment undertaking.
