Objectives and Investment Policy

Objective: The aim of the Fund is to increase the value of an investment over a minimum of 5 years. The Fund will do this through a combination of capital growth, which is profit on investments held, and income received by the Fund, which is money paid out of investments, such as dividends and interest.

Management style: The Fund is actively managed, which means the Investment Manager decides which investments to buy or sell, and when.

Policy: At least 80% of the Fund will be exposed to shares of companies, also known as equities, listed globally.

The Fund may have exposure to shares of companies of varying sizes, from large to small companies. The exposure to small companies (often higher risk) may, at times, be significant.

Exposure to companies will typically be achieved by investing directly, but this exposure can also be indirect, through holding exchange traded funds (ETFs) and collective investment schemes (collectively "Investment Funds"). This may include Investment Funds managed or operated by the Authorised Corporate Director, the Investment Manager or one of their associates.

The Fund may hold up to 20% in cash to enable the ready settlement of liabilities, for the efficient management of the portfolio or in pursuit of the Fund's investment objective.

The Fund can use derivatives or forward transactions, which are instruments whose returns are linked to another asset, market or other variable factor, for efficient portfolio management purposes including the reduction of risk (hedging). The underlying Investment Funds purchased may also have the ability to use derivatives to varying degrees.

The Investment Manager follows a systematic, process-driven approach to determine both the amount allocated to certain areas within global equity markets

and the selection of individual stocks within those specific opportunity areas. A systematic investment approach uses clearly defined rules and processes that are applied consistently over time. This approach aims to minimise the effect of human biases within the investment process.

The Fund invests in specific areas of opportunity identified by the Investment Manager through its quantitative analysis as having the potential to deliver the strongest performance. These opportunity areas may include broad market themes or segments, for example smaller companies or technology related companies.

Within each area of opportunity, the Fund invests in a diversified selection of equities identified through a data-driven screening process that evaluates recent performance and risk characteristics.

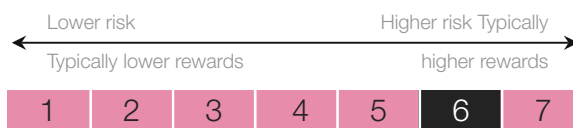
As part of its risk-management approach, there may be times where the Investment Manager replaces a particular opportunity area's direct equity holdings with Investment Funds that are passively managed (where an investment aims to replicate the performance of a specific market index) if performance declines materially within that area. These Investment Funds may be held until conditions within the relevant focus area have improved.

Assessing performance: The Investment Association (IA), the trade body for UK investment managers, has created several 'sectors', as a way of dividing funds into broad groups with similar characteristics. The Fund's Investment Policy puts it in the IA Global Sector.

The Fund is not managed to a benchmark; however you may want to assess the Fund's performance compared to the performance of this sector. This comparator has been chosen as it represents other funds with a similar asset allocation.

Other information: Income is not distributed but is rolled up (accumulated) into the value of your investment. You can buy or sell all or part of your investment on any business day subject to the minimum holding requirements.

Risk and Reward Profile



Investments can go up and down in value and you could get back less than you put in.

This indicator aims to give you a measure of the price movement of this share class based on past data. It uses historic returns over the last five years. If five years' data is not available, simulated data based on a representative portfolio are used.

This Fund has been measured as 6 because its investments have experienced high volatility in the past. The Fund's volatility is affected by various risks, including:

Market risk: The Fund is exposed to financial markets, and market conditions can change rapidly and without warning.

Smaller company risk: The Fund may be exposed to shares of smaller companies, which are typically riskier and harder to sell, compared to larger, more established companies.

Emerging market risk: The Fund may be exposed to emerging markets (a fast-growing economy with increased global trade, but isn't yet considered fully

developed). Investments in these countries can be more volatile and less predictable than in more established markets, increasing risk.

Foreign exchange (currency) risk: The Fund will be exposed to overseas markets and may be affected by changes in currency exchange rates.

Liquidity risk: In difficult market conditions, the Fund may struggle to sell some investments at a fair price, or at all, due to reduced availability of buyers and sellers. This could reduce the Fund's value if investments cannot be sold at a fair price or may cause delays in getting your money back, when you want to sell.

Counterparty risk: The Fund relies on banks and other financial firms to carry out certain services. If one of these firms fails to meet its obligations, the Fund could lose money.

Derivative risk: The Fund may use financial contracts (known as derivatives) to manage risks, reduce costs, or improve returns. However, these strategies may not work as intended.

Operational risk: Failure in systems, people, or processes connected with the Fund's operation, including those related to the safekeeping of the Fund's investments, could lead to losses or inconvenience for investors.

Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment. As this share class does not have 12 months accounting data the ongoing charges figure is based on estimated expenses. This figure may vary from year to year. It excludes:

- Portfolio transaction costs, except in the case of an entry/exit charge paid by the Fund when buying or selling units in another collective investment undertaking.
